Consignment Policies and Application

The Lake Effect Art Gallery is a for profit consignment gallery owned by the Lake Effect Community Arts Center. The Art Gallery has its own board of directors and is staffed completely by volunteers. The Gallery season runs from the week prior to Memorial Day to the Saturday before Thanksgiving.

Please read the following Policies and complete the application on page 2. Bring the completed application and 3-5 pieces of your artwork for jury at a time obtained from one of the contact people listed below.

Consignment Fees:

Consignors who **work 10 days** during the season will pay a **consignment fee of 15%**.

Consignors who **work 5 days** during the season will pay a **consignment fee of 25%**.

Consignors who **work 2 days** during the season will pay a **consignment fee of 35%**.

Non-working consignors will pay a **consignment fee of 40%**.

Submission of Artwork:

All new artists will be initially juried by the Gallery Board. *Accepted artists must jury again if new work presented to the Gallery represents a significant change in their accepted medium or quality of work.* A one time jury fee of \$25.00 will be charged for all accepted artists. The following guidelines will be used:

- Artwork must be original. (Artwork made from kits, made in a class, or incorporating artificial flowers or greenery will not be accepted.)
- New work each year from returning artists is strongly encouraged.
- All work must be individually created by the artist applying to the Gallery.
- Work must be well made, well presented, and completely prepared for display, including mounting hardware.

Our first consideration will be given to artists of the central Upper Peninsula of Michigan. The Board will not accept new art that is too similar in nature or the same type of artwork as already displayed in the Gallery Shop by current consignees.

If artwork is accepted, you will be assigned an inventory code and provided with a contract. Artwork will be put on display only after the contract has been signed and as Gallery space becomes available.

If artwork is not accepted, the artist will be notified to pick up their artwork and the \$25 jury fee will be returned.

The Lake Effect Art Gallery will use ALL reasonable and ordinary care possible in safeguarding and handling items, but is not responsible for breakage or damage to items. The Consignor must assume all losses for their artwork. The Lake Effect Art Gallery assumes no responsibility for artwork.
